

Meeting #4 Agenda Monday, January 22, 2018, 3:30 p.m. ERHS Faculty Cafeteria

I. Welcome/Call to Order

The meeting was called to order at 3:36 pm by Juan Montemayor. The minutes from the December 11, 2017 meeting were read and reviewed. No additions or deletions were suggested. The minutes were approved by the 8 LSLC members present, but this was not an official vote as the 8 members present did not constitute a quorum.

II. Master Scheduling Planning Update

Department course offerings

Mr. Steinorth provided an update on Master Schedule planning for the 2018-2019 school year. He reviewed that departments were asked to clarify which electives they would like to teach and teachers are those courses are both holding informational meetings pertaining to those electives and writing a short description that counselors could refer to when discussing the course with students.

III. Student Discipline/SWPBSC

Mr. Montemayor asked if there was any new information regarding the vandalism of locks on classroom doors that happened before Winter Break. Mr. Steinorth said that no strong suspects had been identified though the investigation was continuing. Ms. La Riva asked about rotation of Campus Supervision Aides on campus during the school day. She would like to know more about where aides are supposed to be at what times. Mr. Steinorth said he was not aware of any set schedule per se for the Aides but that he would ask for more information. Ms. Sanchez asked about the possibility of getting cameras on campus in locations that seem to get the most vandalism.

IV. ERHS Revised Career Pathways

Mr. Steinorth informed the LSLC that there had been a revision of the school's Career Pathways for 11-12th grade students. Ms. Sanchez discussed her Professional Development from Saturday on Linked Learning.

V. ITI Empowered Learner Update

Mr. Steinorth updated LSLC on the progress towards completing the readiness checklist for the school. He said that the second digital citizenship lesson would be explained to teachers during the Faculty Meeting on Tuesday and emphasized how important it is for everyone to complete those lessons to move toward delivery of the one-to-one devices. Mr. Martinez expressed concerns about the difficulties of not having consistent access to computers in completing the requirements of the IB MYP Person Project.

VI. New Business

Mr. Montemayor raised the question of whether the school had the power to switch from Breakfast-In-The-Classroom to the Grab-and-Go food program. Mr. Steinorth said that the school had previously pushed to make this change but were told it would not be allowed by the district. Mr. Montemayor asked if he could see the policy in writing where it said explicitly could not be done. Mr. Steinorth said that he had discussed this request with Lidia Ruiz, the ERHS Cafeteria Manager, who has now written to her superiors in the Cafeteria Branch to see if this information could be obtained.

Ms. La Riva asked if there was to be any discussion of making changes to the Bell Schedule at the school for next year. Both Mr. Steinorth and Mr. Montemayor said that no one had been asking in that regard up to this point in the school year. Mr. Steinorth said that LSLC could obviously open this discussion. When asked, Ms. La Riva expressed that the loss of the Nutrition period was an issue that she would like to see addressed in a revision of the Bell Schedule. Mr. Martinez said that Nutrition was more useful than Office Hours that are currently part of the schedule. Mr. Steinorth answered that Office Hours were the method that the school used to meet the contractual obligation of minutes worked for the school, but he also added that he see's a need for a return to having an Advisory period to be able to better utilize the Naviance College planning software that the district has purchased for schools. The council members asked for this to be placed on the agenda for the next meeting.
